- 1) The project as designed does not create a high quality environment for all the residents.
  - 2) The project does not contain an affordable unit as is required by the VCZSP.
  - 3) The project has 4 units instead of the allowable 2 and are not proposing a 3 units where one is affordable as required by the VCZSP.
  - 4) If the VCZSP allowed four units on this lot, it would require 9 parking spaces, including one guest parking space. The proposed project includes 8 parking spaces and no guest parking space.
  - 5) The project violates the VCZSP because it does not comply with the density, parking and affordable housing requirements of the VCZSP.
  - 6) The project also violates the VCZSP because it is not compatible in character with the density and mass of the neighborhood.
  - 7) The project ignores the prevailing set back in the neighborhood as specified by the Small Lot Sub division guidelines.
  - 8) The project does not mesh well with the existing neighborhood context
  - 9) The project does not enhance the public realm.
  - 10) Where there is a lot area that would allow the additional units 64% of the lots have applied for additional units resulting in the cumulative increase in density of 41%.

ReStore starts with "eco" canvases made from recycled billboard vinyl(thrown into landfills by the ton monthly) The material is stretched onto hard panels measuring 4 x 8 feet. By putting modules together the system produces large(8 x 16 feet) easily installed exterior murals. A typical \$4000 NPG grant will allow for 4 murals to be displayed over a

period of 12 months (3 additional months if within a LANI improvement zone) with the works changed out quarterly. 2 of the murals will be original works created by stakeholders from within the Venice NC. ReStore images will be bold, engaging and accessible. Many of the works will be “paint by number” simple so that school kids and community groups can create them with a good level of execution. The pieces can be produced over time or more spontaneously at street fairs, farmer’s markets, art walks, or neighborhood outreach events. Install sites initially will be at public school campuses.

Once installed Project ReStore murals will add new energy to tired and seemingly forgotten streets. And in being created from within the community, neighborhood pride in and ownership of the imagery will result. From experience with youth public art installations in the past, Eco-LogicalART has also proven that the works also help to mitigate graffiti. Additionally the program also offers youth a positive--and legal way of expressing themselves visually.
